■ Foreign Currency Exchange

Taiwan currency unit is called the New Taiwan Dollar (NT\$). Major currencies and

traveler's checks can be exchanged into NT\$ at the airport, financial service outlets, banks and hotels. Current exchange rate for 1 US\$ equals to about 30 NT\$.

■ Passport and Visa Requirements

Foreign visitors must present valid passports with at least 6 months before expiration. Visa requirements are waived for visitors from the OECD and many other countries. For visitor visa requirement of your local area, please check with the nearest office of Taipei Economic and Cultural Office (TECO). Visitors from PRC may apply for individual travel plan (free-go-about) with travel agencies of several major cities in Mainland. Visitors so engaged will be allowed 15 days of traveling, including partaking in conference in Taiwan. Others may require special exit and entry permits to come to Taiwan.
